


T7.1: Validation roadmap

- define national roadmap
- create methods and tools for validation
- set benchmarks
- use input from national contact points
- reuse data, tools, benchmarks, results from ARROW
- Deliverable: M18 (= September 2012)



ARROW – from the validation view





- □ T7.2. Internal testing
 - "System approach"
 - Improvements of the system
 - New functionality
 - New workflows
 - Testing could take place on basis of data already used in ARROW and/or new data
 - Partners without national workflow could use national solutions from other countries (e.g. Germany)



T7.3 Metadata enrichment (new registries)

- "National approach"
- Evaluation of new registries
- Data conversion
- Inclusion of national databases
- Consistency of databases
- Responsibility stays mainly with WP5



T7.4 Stakeholder validation

- Overall validation from the point of view of stakeholders
- **Full adopters vs. partial adopters**
- Different communities and different interests
- □ Final deliverable: M30 (= September 2013)



Challenges, open issues

- Complex situation
 - so many countries, so many workflows, so many data sources, so many interest groups
 - work closely together with technical partners and national contact points (resp. FEP als coordinator of national contact points)
- ARROW system
 - Further development: Shall it play a role within the validation, and if yes, which one? Reviewers might ask and use ARROW as benchmark for ARROW+
 - Clarify the situation during first review
- Still images
 - A completely new situation we are dependent on plans and decisions which will be made during the next months
 - validation plan will be decided together with EVA, CEPIC
- Design of new tools for right holder involvement
 - New tools shall allow that right holders claim/declare their rights directly
 - Test scenario for large scale digitisation of "German Dissertations" (UIBK)
 - A decision will soon be made on this issue
