

- □ Identifying ongoing business models for new registries → WP3 national sustainability plans






#### **WP5 Main Criticalities**



Description of possible risk	Impact	Probability of occurrence	Remedial Actions
Sustainability analysis for BIP shows lack of sustainability of the BiP infrastructure in certain countries in the absence of continuing external funding	Difficult sustainability after project end of one crucial element of the system, affecting the whole	high (limited to few countries)	Plans for adjusting the infrastructure so to incorporate other sources of information will be designed. Plans for additional fund raising for the countries that need elaborated. Additional consulting of the possibilities to operate the system on low costs.
Lack of in-country consensus on requirements	Delays in implementation and reduced performance of the system	medium	The technical group will set the minimal requirements needed to ensure efficient running of the system that must be implemented; bench-marking will be exploited to foster consensus on enhanced requirements that can be implemented progressively


